Booking Conditions

Making a Booking: Once you have made a verbal booking, it will be held for three days, in order to give you time to send a completed Booking Form and the advance rental (see below). On receipt of these, your booking will be confirmed in writing.

Advance Rental: This is half of one week's rent, and is payable with your Booking Form. We send written receipts for all payments.

Security Deposit: This is a deposit of £250 in case of damage or in case extra cleaning is necessary. The rent includes three hours of cleaning time after your departure, and if more than this is required, we reserve the right to deduct its cost. Subject to that, the deposit is returned within a week of the end of your stay.

The balance of rent, plus the security deposit, is due two months before the starting date. On receipt of the balance, we send out joining directions, including the name and telephone number of our (English) house manager. If your booking is made within two months of the start of your visit, full payment is required at the time of booking.

Arrival and Departure: The letting begins at 5PM on the Saturday you have chosen. On the Saturday of your departure, please vacate the property by 10 AM. This gives time for proper cleaning between visitors leaving and visitors arriving.

Care: You agree to be a considerate tenant, to take good care of Nougayrede and to leave it in a good state of cleanliness.

Problems: We hope you will have none, but if there are any defects or snags arising during your stay, our local manager will make every reasonable effort to rectify them. We ask you to report any such matters to her immediately, and she will ensure that arrangements for repair or replacement are made as quickly as possible.

Numbers of People: We ask you not to have more people at Nougayrede than you have notified to us.

Cancellation: If you cancel the booking, we will try to re-let the property. If we succeed, we will refund the rent you have paid, less any expenses or losses incurred. If we do not re-let, we cannot undertake to return the rent that has been paid.

Liability: Use of the property, pool, grounds, buildings, whether occupied or not, is at the tenant's risk and no liability is accepted by the owner for injury, loss or suffering of any type by tenants at the property. We shall not be liable to the tenant for any temporary defect or stoppage in the supply of public services to the property, nor in respect of any equipment in the property, garden or pool, or for any loss, damage or injury resulting from matters beyond our control.
